

The Story of the Divine Class-Action Lawsuit

One morning, in the summer of 2003, as I was pondering the numerous evil acts of the enemy, I said something like this: “You know, Lord, we ought to just sue the devil.”

No sooner did those words leave my mouth than a powerful anointing began to pour down on me, and I knew what the Lord wanted me to do: To come before the heavenly court and file a class-action lawsuit on behalf of the Body of Christ against the devil. So after some library research, the Holy Spirit and I began writing the class-action lawsuit. The entire petition is based upon the Bible, the word of the Living God. It is the very foundation, and it comes from the very heart of God.

It took several months to complete, but it was an urgent and serious matter to the Lord. After completion, I submitted it to my prayer partners for prayer and review. Copies were made and sent to the potential signers, who reviewed it with prayer. Upon their agreement, both to its content and to the great responsibilities as a signer, the original was hand-carried to each to sign. Each was given a copy to uphold in prayer.

When I went before the heavenly court to present our case, I read the entire document before our King Who sat upon His throne. In attendance was Satan, the twenty-four elders, numerous angels and other beings that I cannot describe. I also had a sense that this event was being witnessed by a great company of believers in heaven. After presenting our case, I saw an angel seated in the center of a room at a high desk or table with a slanted top. This room was filled with books and he began to search through them. I knew that he was researching the details of all of the claims made in the lawsuit.

It was sometime in the next year of 2004 that the Lord revealed that our petition had been approved by the council in heaven. In this year, the Lord showed me a vision. I saw our petition grow wings and fly around the world over and over again.

It was shortly thereafter that I realized that this document continues to evolve as the Lord reveals more territory that needs to be addressed and legally obtained. This class-action lawsuit does not just seek to restore our earthly possessions and authority, and recompense wrongs suffered, but also those possessions and authority in the heavenly realms (i.e., the first and the second heavens, 2 Corinthians 12:2) over which God always intended man to rule (Hebrews 2:5-8; Psalm 8:4-6).

The summer of 2006 marked the third anniversary of the beginning of this class action lawsuit, yet I was just beginning to receive understanding from the Lord why this document was necessary. After all, the Bible is a totally legal, binding and official document of our inheritance. It includes the last will and testament of our Lord and Savior Jesus Christ, the Messiah. This is the way the explanation came to me: We are citizens of the kingdom of heaven on assignment here on earth. Our kingdom has a King (The Lord Jesus) Who is also The Judge. Isaiah 33:22 says, “For the Lord is our Judge, the Lord is our Lawgiver, the Lord is our King; He will save us.”

Editor's Note: When many of the modern nations of the world were first established, they used our American constitution as a pattern. But when the forefathers of our nation established the constitution, they didn't have any nation to look to. Rather, they looked to the Holy Bible. They found one verse that referred to an executive branch, a legislative branch, and a judicial branch. It was Isaiah 33:22 which speaks of a King [the executive], a Lawgiver [the legislative] and a Judge [the judicial branch]. The constitution of the United States was founded on this verse in the Holy Bible: Isaiah 33:22. JLM

The Bible says in Hebrews 10:30 “...The Lord will judge and determine and solve and settle the cause and the cases of His people.”

According to Isaiah 9:7, our kingdom has a government that is ruled by our King: “... the government shall be upon His shoulder,... Of the increase of His government and of peace there shall be no end...” Daniel 7:10 wrote about “a heavenly court,” and “...the Judge was seated [the court was in session]... and Daniel 7:26 says “...the judgment shall be set [will be unchangeable]...” The judgments of this court are legal and binding.

In general, a losing defendant in civil litigation... reimburses the plaintiff for losses caused by the defendant's

behavior. It is the same way in the heavenly court. Our heavenly court has already brought criminal charges against Satan for his criminal conduct. He has already been tried, found guilty, and sentenced according to Revelation 20:10 "...the devil, who deceived them, was cast into the lake of fire and brimstone where the beast and the false prophet are. And they will be tormented day and night forever and ever."

All that remained to be done was the filing of the civil action against Satan. This was accomplished in October of 2003. A verdict in our favor was rendered in 2004 and is now being enforced by God Himself through His people. We have been awarded our judgment and there IS NO HIGHER COURT of appeals for the enemy. This has resulted in the largest judgment ever issued by any government to any people in the history of the world! We need our portion of this judgment to fulfill His commission to make disciples of all nations. We need the ability to do whatever the Lord is directing us to do, whenever He directs us to do it, however He directs us to do it! We not only need to get the Lord's work done, but we need to be an example of the goodness of God by allowing His glory to be seen in and upon us and our households. Some of us will receive material wealth and provision for many others which we are to **faithfully distribute** as the Lord directs so that they can fulfill their destinies and His mandates. But this is not just about money. Many have been robbed of due honor and recognition. Others have been robbed of ideas and discoveries because of Satan's tactics. Can you imagine what you could do for God if there was no lack of anything?

Truly it is more blessed to give than to receive. But you've got to receive at some point so that you'll have something to give. It's time to use this class action judgment as the basis for your claims against the enemy. It's based on the Word of God. It's backed by all the forces of heaven. Our requests have been granted. It's time to **MAKE THE DEVIL PAY!**

There is also another reason why a class action was needed. We've been standing against the enemy individually, and sometimes in groups of varying size. But what was needed was for all of us to stand against the enemy as ONE, UNITED, in ONE SPIRIT, of ONE MIND, in ONE ACCORD, along with ALL the saints in heaven, to obtain a legal and binding judgment on behalf of us ALL against the kingdom of darkness for ALL of their atrocities since the beginning of time. As we come together in unity, the power increases exponentially. If five of us can chase a hundred, and a hundred can put ten thousand to flight, what can millions of us do (Leviticus 26:8)?

Those of us who KNOW who we are in Christ and what belongs to us must stand in the gap for our brethren who do not yet know these things. Remember, at some point, WE did not know these things. As we receive on their behalf, we can send preachers and teachers to them, and we can give to them those portions that the Lord entrusts into our hands for them. Just think of it. What has the enemy stolen from your ancestors? That was part of your inheritance! What has the enemy stolen from you? This is the end of the end time and the harvest is ripe. It's time to receive EVERYTHING that Jesus paid for on the cross. I am sharing this Vision from the Lord which I received June 04, 2002: As I was praising and worshiping the Lord in my morning prayer time, I suddenly was part of a vision. I saw the devil's house. I saw Satan standing on the far side in front of the house.

The Lord and I stood on the other side. The Lord had a clipboard in His hand with a thick stack of papers on it. A multitude of angels appeared and went into the house. They came out, one by one, each carrying a box or furniture. As Satan began to open his mouth to protest, a wide band of gray duct tape flew across his mouth and he could not speak.

As the angels came out one by one, the Lord would check off an item on the lists. Angels were even pushing things out through the windows. There was one angel standing outside of a window pulling an object out as another was pushing the same item out through the window from the inside.

I saw 2 items on one page of the checklists: one item was gold and the other, silver. As I saw the Lord check off these items, He said, "The gold is Mine and the silver is Mine." He was also saying something about 7 of this and 7 of that for each item that was taken. And I heard something about restoring what the cankerworm and the palmerworm had eaten.

There was a constant procession of angels going in empty handed and coming out carry something. Some rolled out wheel-barrels full of gold and jewels.

Then I saw angels carrying people out! When I saw this I began to shout praises to God at the top of my lungs, and I fell down to worship Him. As soon as I began praising Jesus, all the angels stopped what they were doing. They put down whatever they were carrying and began praising God with me. They also fell down before Jesus, and we all shouted and praised and praised and shouted!

As we were doing this, Jesus pointed His finger at Satan, and he was forced down on one knee by an unseen force. He had an anguished look on his face. As we continued to praise, he was forced down on the other knee.

By now I was so full of the presence of God that I fell backwards before the Lord. Then the praise quieted down and the angels went back to work. I was on my back, but I could still see what was going on. I saw the entire house split open from the side. The front half of the house moved forward and the back half of the house moved backward (like a giant doll house). Now, huge items began to emerge from the house. I saw planes, cars, boats and even an ocean liner came out. They seemed to be coming out of the ground and up out of the house, as if they came from an endless black hole. I came

out of the spirit and was totally full of the presence of the Lord.

I. IN THE DISTRICT COURT OF HEAVEN FOR THE DISTRICT OF THE EARTH

The signers of this petition, on behalf of themselves and others similarly situated, and redeemed by the blood of Yeshua ha Mashiach YHVH (Jesus the Anointed LORD), the Lamb of God,
Plaintiffs,

Satan, all principalities, powers, rulers of the darkness of this age, spiritual hosts of wickedness in heavenly places, and any and all other demonic entities, along with co-defendants (all persons, organizations, governments, and any other participants, who knowingly or unknowingly, acted under their influence, direction or control).

Now come the signers of this petition, on behalf of themselves and others similarly situated, those redeemed by the blood of the Lamb of God, Jesus Christ, and for their complaint stated as follows:

II. PARTIES

PLAINTIFFS

The plaintiffs and those whom they represent, all former citizens of earth, have transferred citizenship to heaven, and have proper standing to bring the suit based on *Philippians 3: 20** (*"For our citizenship is in heaven, from which we also eagerly wait for the Savior, the Lord Jesus Christ."*), *Ephesians 2:19* (*"Now, therefore, you are no longer strangers and foreigners, but fellow citizens with the saints and members of the household of God,"...*) and *Hebrews 12:23 (Amp)* (*... "and to the church [assembly] of the Firstborn who are registered [as citizens] in heaven,"...*).

DEFENDANTS

Defendants Satan, all principalities, powers, rulers of the darkness of this age, spiritual hosts of wickedness in heavenly places, and any and all other demonic entities, former residents of heaven, properly and permanently evicted as renegades (*Revelation 12:7-9; Ezekiel 28:14-19; Luke 10:18*), currently citizens of hell (*Isaiah 14:12-15*), and future residents of the Lake of Fire and Brimstone (*Revelation 20:10*), therefore differing in citizenship from the plaintiffs. Co-defendants (all persons, organizations, governments, and any other participants, who knowingly or unknowingly, acting under their influence, direction or control) are citizens of earth, subdivided by nationality, also differing in citizenship from the plaintiffs.

Revelation 12:7-9 – "And war broke out in heaven: Michael and his angels fought against the dragon; and the dragon and his angels fought, 8 but they did not prevail, nor was a place found for them in heaven any longer. 9 So the great dragon was cast out, that serpent of old, called the Devil and Satan who deceives the whole world; he was cast to the earth, and his angels were cast out with him."

Ezekiel 28:14-19 – “You were the anointed cherub who covers; I established you; you were on the holy mountain of God; you walked back and forth in the midst of fiery stones, 15 you were perfect in your ways from the day you were created, till iniquity was found in you. 16 By the abundance of your trading you became filled with violence within; and you sinned; therefore I cast you as a profane thing out of the mountain of God; And I destroyed you, O covering cherub, from the midst of the fiery stones. 17 Your heart was lifted up because of your beauty; you corrupted your wisdom for the sake of your splendor; I cast you to the ground, I laid you before kings, that they might gaze at you. 18 You defiled your sanctuaries by the multitude of your iniquities, by the iniquity of your trading; therefore I brought fire from your midst; it devoured you, and I turned you to ashes upon the earth in the sight of all who saw you. 19 All who knew you among the peoples are astonished at you; you have become a horror, and shall be no more forever.”

Luke 10:18 – “And He said to them, ‘I saw Satan fall like lightning from heaven’.”

Isaiah 14:12-15 – “How you are fallen from heaven, O Lucifer, son of the morning! How you are cut down to the ground, you who weakened the nations! 13 For you have said in your heart: “I will ascend into heaven, I will exalt my throne above the stars of God; I will also sit on the mount of the congregation on the farthest sides of the north; 14 I will ascend above the heights of the clouds, I will be like the Most High.” 15 Yet you shall be brought down to Sheol, to the lowest depths of the Pit.”

Revelation 20:10 – “And the devil, who deceived them, was cast into the lake of fire and brimstone where the beast and the false prophet are. And they will be tormented day and night forever and ever.”

III. JURISDICTION

The basis for heavenly court jurisdiction is diversity of citizenship (the citizenship of all plaintiffs is heaven, the citizenship of all primary defendants is hell, and the citizenship of all co-defendants is earth.) For each and every class member (represented in this lawsuit by the named plaintiffs), the amount in controversy far exceeds the range, scope and ability of any earthly court to award, execute or enforce judgment.

IV. CLAIMS FOR RELIEF

A. Although the scriptures clearly and firmly establish the citizenship of the plaintiffs as heaven, the scriptures also equally establish the rights of the plaintiffs to dominate, rule, reign and inherit the earth and any and all resources contained therein. The Bible says in Psalm 24:1-2, “The earth is the Lord’s and all it’s fullness, the world and those who dwell therein. For He has founded it upon the seas, and established it upon the waters.”

Therefore, the ownership of the entire earth and all of it’s fullness (i.e., everything in it) belongs to the Lord God Almighty. The Word of God also states in Psalm 47:7, “For God is the King of all the earth; sing praises with understanding.” As King and Owner of the earth, God has the right to delegate His authority and apportion an inheritance to whomsoever He desires. God has given man dominion (complete authority) over all of the earth, has appointed man as ambassadors to the earth and has given man an inheritance of the earth as evidenced by the scriptures below:

- Genesis 1:26 – “Then God said, ‘Let Us make man in Our image, according to Our likeness; let them have dominion over the fish of the sea, over the birds of the air, and over the cattle, over all the earth and over every creeping thing that creeps on the earth’.”
- Genesis 1:28 – “Then God blessed them, and God said to them, ‘Be fruitful and multiply; fill the earth and subdue it; have dominion over the fish of the sea, over the birds of the air, and over every living thing that moves on the earth.’”
- 2 Corinthians 5:20 – “Therefore we are ambassadors for Christ, as though God were pleading

through us: we implore you on Christ's behalf, be reconciled to God."20 (Note: Ambassador = a diplomatic official of the highest rank approved and accredited as representative in residence by one government to another).

- Psalm 25:12-13 – “Who is the man that fears the Lord? Him shall He teach in the way He chooses. 13 He himself shall dwell in prosperity, and his descendants shall inherit the earth.”
- Psalm 37:9 – “For evildoers shall be cut off; but those who wait on the Lord, they shall inherit the earth.”
- Psalm 37:11 – “But the meek shall inherit the earth, and shall delight themselves in the abundance of peace.”
- Psalm 115:16 – “The heaven, even the heavens, are the Lord's; But the earth He has given to the children of men.”
- Matthew 5:5 – “Blessed are the meek for they shall inherit the earth.”
- 2 Corinthians 6:2 – “...Behold, now is the accepted time; behold, now is the day of salvation.”

B. The most compelling argument for relief that establishes the legal right of the plaintiffs (and those whom they represent) as heirs of God through Yeshua ha Mashiach YHVH (Jesus the Anointed LORD) is based upon the everlasting blood covenant between God, Abraham and Abraham's seed. The following scriptures form the basis for this assertion.

- Genesis 17:7 – “And I will establish My covenant between Me and you and your descendants after you in their generations, for an everlasting covenant, to be God to you and your descendants after you.”
- Galatians 3:13-14 – “Christ has redeemed us from the curse of the law, having become a curse for us (for it is written, ‘Cursed is everyone who hangs on a tree’), 14 that the blessing of Abraham might come upon the Gentiles in Christ Jesus, that we might receive the promise of the Spirit through faith.”
- Galatians 3:29 – “And if you are Christ's, then you are Abraham's seed, and heirs according to the promise.”
- Romans 4:13, 16 (AMP) – “For the promise to Abraham or his posterity, that he should inherit the world, did not come through [observing the commands of] the Law but through the righteousness of faith.” 16 “Therefore, [inheriting] the promise is the outcome of faith *and* depends [entirely] on faith, in order that it might be given as an act of grace (unmerited favor), to make it stable *and* valid *and* guaranteed to all his descendants—not only to the devotees *and* adherents of the Law, but also to those who share the faith of Abraham, who is [thus] the father of us all.”
- Galatians 4:7 – “Therefore you are no longer a slave but a son, and if a son, then an heir of God through Christ.”
- Hebrews 6:17-18 – “Thus God, determining to show more abundantly to the heirs of promise the immutability of His counsel, confirmed it by an oath, 18 that by two immutable things, in which it is impossible for God to lie, we might have strong consolation, who have fled for refuge to lay hold of the hope set before us.”
- Deuteronomy 8:18 – “And you shall remember the Lord your God, for it is He who gives you power to get wealth, that He may establish His covenant which He swore to your fathers, as it is this day.”
- Deuteronomy 7:9 – “Therefore know that the Lord your God, He is God, the faithful God who keeps

covenant and mercy for a thousand generations with those who love Him and keep His commandments;”

- Matthew 26:28 – “For this is My blood of the new covenant, which is shed for many for the remission of sins.”
- Psalm 25:14 – “The secret of the Lord is with those who fear Him, and He will show them His covenant.”
- Psalm 89:28,34 – “My mercy I will keep for him forever, and My covenant shall stand firm with him. 34 My covenant I will not break, nor alter the word that has gone out of My lips’.”
- Isaiah 54:10 – “For the mountains shall depart and the hills be removed, but My kindness shall not depart from you, nor shall My covenant of peace be removed,’ says the Lord, who has mercy on you.”
- Hebrews 13:20-21 – “Now may the God of peace who brought up our Lord Jesus from the dead, that Great Shepherd of the sheep, through the blood of the everlasting covenant, 21 make you complete in every good work to do His will, working in you what is well-pleasing in His sight, through Jesus Christ, to whom be glory forever and ever. Amen.”
- Isaiah 49:8-9 – “In an acceptable time I have heard You, and in the day of salvation I have helped You; I will preserve You and give You as a covenant to the people, to restore the earth, to cause them to inherit the desolate heritages (inheritances); 9 that You may say to the prisoners, “Go forth,” to those who are in darkness, “Show yourselves.””

C. We further assert that the plaintiffs have been given the right to dominate, rule and reign over the universe, present and future (Revelation 21:1; Isaiah 65:17; 66:22; 2 Peter 3:7, 13) including the stars, planets, and everything therein, under the authority of the Lord Jesus Christ, Who, being the appointed Heir and lawful Owner, has put everything under man’s control.

- Hebrews 1:2 (Amp) - “[But] in the last of these days He has spoken to us in [the person of a] Son, Whom He appointed Heir and lawful Owner of all things, also by and through Whom He created the worlds and the reaches of space and the ages of time [He made, produced, built, operated, and arranged them in order].“
- Deuteronomy 10:14 (Amp) – “Behold, the heavens and the heaven of heavens belong to the Lord your God, the earth also, with all that is in it *and* on it.”
- Nehemiah 9:6 (Amp) – “[And Ezra said], You are the Lord, You alone; You have made heaven, the heaven of heavens, with all their host, the earth, and all that is on it, the seas and all that is in them; and You preserve them all, and the hosts of heaven worship You.”
- Psalm 33:6 (Amp) – “By the word of the Lord were the heavens made, and all their host by the breath of His mouth.”
- Psalm 89:11 (Amp) – ” The heavens are Yours, the earth also is Yours; the world and all that is in it, You have founded them.”
- 1 Corinthians 3:21-23 (Amp) - “So let no one exult proudly concerning men [boasting of having this or that man as a leader], for all things are yours, 22 Whether Paul or Apollos or Cephas (Peter), or the universe or life or death, or the immediate *and* threatening present or the [subsequent and uncertain] future—all are yours, 23 And you are Christ’s, and Christ is God’s.”
- Hebrews 2:5-8 (Amp) - “For it was not to angels that God subjected the habitable world of the future, of which we are speaking. 6 It has been solemnly *and* earnestly said in a certain place, What is man

that You are mindful of him, or the son of man that You graciously *and* helpfully care for *and* visit *and* look after him? 7 For some little time You have ranked him lower than *and* inferior to the angels; You have crowned him with glory and honor *and set him over the works of Your hands*, 8 For You have put everything in subjection under his feet. Now in putting everything in subjection to man, He left nothing outside [of man's] control. But at present we do not yet see all things subjected to him [man].

- Psalm 8:4-6 (Amp) - "What is man that You are mindful of him, and the son of [earthborn] man that You care for him? 5 Yet You have made him but a little lower than God [or heavenly beings], and You have crowned him with glory and honor. 6 You made him to have dominion over the works of Your hands; You have put all things under his feet:"

D. The nature and character of the primary defendant (Satan) is clearly set forth in scripture. In the word of God, he is called:

- The adversary of believers (1 Peter 5:8)
- The accuser of our brethren (Revelation 12:10)
- Beelzebub, ruler of the demons (Matthew 12:24)
- The ruler or prince of this world (John 12:31; 14:30)
- The god of this world (2 Corinthians 4:4)
- The prince of the power of the air (Ephesians 2:2)
- Belial (worthlessness, ungodliness, the Engulfer)
(2 Corinthians 6:15; Judges 19:22)
- The father of lies (John 8:44)
- Murderer (John 8:44)
- The tempter (Matthew 4:1, 3; 1 Thessalonians 3:5)
- The king of death (Hebrews 2:14)
- The wicked one (Matthew 13:19)
- The thief (John 10:10)
- The enemy (Matthew 13:39)
- The angel of the bottomless pit (Revelation 9:11)
- Abaddon (Destruction) (Revelation 9:11)
- Apollyon (Destroyer) (Revelation 9:11)
- The dragon or great dragon (Revelation 12:7, 9; 20:2)
- The serpent of old (Revelation 12:9; 20:2)
- The deceiver (Revelation 20:10)

Each of his titles is clearly attested to by his actions. Whatever means he uses, whatever stratagem he employs, whatever device he devises, his ultimate goal is to kill, steal and destroy, with a particular abhorrence for born-again believers and the children of Israel.

We, the plaintiffs, allege that the defendant and the co-defendants have murdered many of the saints of God, many of our ancestors, relatives and friends. We allege that the defendant and the co-defendants have stolen our property and our rightful inheritance. We further allege that they have destroyed many of the people of God, and have stolen their health and peace of mind. We call upon the High Court of Heaven to call forth the angelic historians to bring forth the records to examine and establish the full extent to which the defendant and the co-defendants have assaulted the people of God, beginning with the rebellion (Ezekiel 28:12-19) even unto this day. We enter into evidence the Bible, the holy word of God, as Exhibit A, the historical record as Exhibit B and call as witnesses all of the saints to testify against the defendant and the co-defendants. We also call the three who bear witness in heaven (The Father, the Word and The Holy Spirit), and the three that bear witness on earth (The Spirit, the water and the blood) to testify on our behalf (1 John 5:7-8). We submit the list below as but a few examples that the defendants and co-defendants have:

- Murdered our ancestors through the institution of slavery, through massacre (by individuals and vigilante groups), through sickness and disease, through starvation, and through any and every means possible in direct violation of the sixth commandment. (Ex. 20:13; Job 1:12-19; Ephesians 2:2; John 8:44, 10:10; James 5:1-6; Hebrews 11:36-39)
- Destroyed or caused the destruction of the personal property of our relatives, ancestors, and ourselves through acts of violence (by individuals and vigilante groups), and through acts deceitfully labeled as “acts of nature” or as “acts of God” and through any and every means possible. (Job 1:12-19; Ephesians 2:2; John 8:44, 38, 41; 10:10).
- Withheld wages (in full or in part) rightfully earned by our relatives, ancestors and ourselves (slave or free). (James 5:4)
- Inspired the U.S. government to renege on the promise of land and livestock to each slave when they were freed. (Ephesians 2:2; John 8:44, 38, 41; Rev. 16:13-14)
- Inspired the U.S. government to steal land from our Native American ancestors. (John 10:10)
- Inspired unjust laws of exclusion against the rights of our ancestors, which limited their influence in commerce, in education, in political and social arenas and in personal development. (Ephesians 2:2; John 8:44, 38, 41; Rev. 16:13-14)
- Stolen the seeds, harvests, giftings and anointings of our relatives, ancestors, and ourselves through lies and subterfuge. (2 Cor. 4:3-6; 1 Peter 5:8; Mark 4:3-20)
- Kept doors of opportunities shut and blocked fair and equal treatment from our relatives, ancestors, and ourselves through prejudice, bigotry and hatred. (Ephesians 2:2; John 8:44, 38, 41)
- Enslaved, murdered and plundered the children of Israel by inciting hatred and fear (anti-Semitism) throughout their history (including atrocities of Nazi Germany). (Exodus 1:8-11)

V. CLASS ACTION AVERMENTS

Now come the plaintiffs and those whom they represent, to move this Honorable Court to certify this proceeding as a class action against defendants Satan, all principalities, powers, rulers of the darkness of this age, spiritual hosts of wickedness in heavenly places, and any and all other demonic entities, along with co-defendants (all persons, organizations, governments, and any other participants, who knowingly or unknowingly, acted under their influence, direction or control). The substantial grounds upon which this motion is based are set forth in the supporting documentation below.

A. The following scriptures demonstrate the elements of numerosity, commonality and typicality which, taken together, provide the basis for class certification.

Numerosity

Romans 8:29 – “For whom He foreknew, He also predestined to be conformed to the image of His Son, that He might be the firstborn among many brethren.”

1 Corinthians 12:12 – “For as the body is one and has many members, but all the members of that one body, being many, are one body, so also is Christ.”

1 Corinthians 12:14 – “For in fact the body is not one member but many.”

1 Corinthians 12:20 – “But now indeed there are many members, yet one body.”

Acts 2:47 – ...”And the Lord added to the church daily those who were being saved.”

It is evident there are too many brethren for each to bring a separate lawsuit against the defendants, and that number increases daily.

Commonality/Typicality

1 Peter 5:8-9 – “Be sober, be vigilant; because your adversary the devil walks about like a roaring lion, seeking whom he may devour. 9 Resist him, steadfast in the faith, knowing that the same sufferings are experienced by your brotherhood in the world.”

1 Corinthians 12:26 – “And if one member suffers, all the members suffer with it; or if one member is honored, all the members rejoice with it.”

Revelation 12:17 – “And the dragon was enraged with the woman, and he went to make war with the rest of her offspring, who keep the commandments of God and have the testimony of Jesus Christ.”

The primary defendant seeks to devour the brethren, and we all experience the same sufferings at his hand. He specifically targets all those who keep God’s commandments and have the testimony of Jesus Christ.

Other Factors

Genesis 3:13 – “”And the Lord said to the woman, “What is this you have done?” And the woman said, “The serpent deceived me, and I ate.””

1 Timothy 2:14 – “And Adam was not deceived, but the woman being deceived, fell into transgression.”

The very nature of the tactics of the defendant prevents a large portion of the brethren from recognizing his handiwork, thus making it impossible for them to represent themselves in this lawsuit.

B. The following scriptures demonstrate the adequacy of representation of the plaintiffs on behalf of the entire Body of Christ.

1 Corinthians 14:20 – “Brethren, do not be children in understanding; however, in malice be babes, but in understanding be mature.”

Philippians 3:14-15 – “I press toward the goal for the prize of the upward call of God in Christ Jesus. 15 Therefore let us, as many as are mature, have this mind; and if in anything you think otherwise, God will reveal even this to you.”

Hebrews 5:14 – “But solid food belongs to those who are of full age, that is, those who by reason of use have their senses exercised to discern both good and evil.”

Adequacy of Representation

The plaintiffs collectively have over 300 years experience in the Christian faith. They are leaders, pastors and entrepreneurs. They are husbands, wives, fathers, mothers, sons and daughters. They know and feed on the meat of the word of God. But perhaps most importantly, they are not ignorant of Satan’s devices and have tasted the goodness of the Lord and the truth of His word. Their eyes have been opened and the enemy of their souls has been exposed. They walk in the authority given them in Yeshua ha Mashiach YHVH (Jesus the Anointed LORD) and declare His word in the earth. They are submitted to God and to one another. They are not strangers to warfare and have emerged victoriously through many trials and tribulations. They come, not only on their behalf, but also on behalf of all of their brethren. The plaintiffs, being bound by the law of love, will fairly and adequately protect the interests of absent class members. They rely upon the Lord to administer equitable awards of judgments to those who qualify, according to the extent of the damage suffered against them, their ancestors and their relatives.

VI. PRAYER FOR RELIEF

A. We, the plaintiffs, respectfully demand class certification be granted and judgment be entered on the claims asserted. We respectfully demand full restoration, restitution, adequate compensation and complete and immediate transfer of ownership into the hands of qualified plaintiffs of all resources of the earth according to the word of God. This includes, but is not limited to:

1. Compensation for pain and suffering.
2. The seven-fold double return of all interest, penalties and unjust fees and charges including, but not limited to those incurred through taxes, loans and credit cards.
3. The seven-fold double return of all real property stolen through demonically induced disasters, including but not limited to earthquakes, fires, floods, tsunami's, hurricanes, tornado's, and whatever appeared to be freak accidents.
4. The seven-fold double return of all monies spent on sinful activities, including, but not limited to money spent on illegal drug use and the abuse of legal drugs and alcohol.
5. The seven-fold double return of the value of time lost and the costs of delays resulting from Satan's attacks, influence or control including, but not limited to the time to rebuild, repair or restore. We also request the affected plaintiffs receive compensation for all hindrances and that all participating defendants receive additional punishment.
6. The return of all territories in every realm, natural and spiritual.
7. The seven-fold double return of all God-given gifts, anointings, mantles, revelations, ideas, inventions, discoveries, influence, wisdom, knowledge (covering all areas, including, but not limited to: scientific, medical, technological, biological, agricultural, archeological, astronomical and in literature and the arts) and every other God-given thing not utilized and accredited to the full to ourselves and our ancestors as a result of the activities of Satan and his minions.
8. The seven-fold double return of due honor, recognition and acknowledgment.
9. The seven-fold double return of all unpaid or underpaid wages, salaries, tips, inheritances, accounts, etc.
10. The seven-fold double return of all unjust judgments and decisions against us.
11. The double return of all forfeitures.
12. The complete and full restoration from and compensation for any and all negative, damaging effects of Satan's attacks, influence, stratagems or devices against our spirits, souls, physical bodies or physical property.
13. The transfer of ownership and control of all satellites and all communication devices including, but not limited to, television, radio (including shortwave radio), all cyberspace (including the internet), all telephones, magazines and newspapers.
14. The transfer of ownership and control of all transportation including, but not limited to all automotive vehicles, aeronautical vehicles, sea-faring vessels and military transports.
15. The transfer of ownership and control of all corporations, companies and businesses, all medical and care-giving facilities, all research facilities, civilian and military, that endorse, support and/or practice ungodly, immoral, illegal, unjust or unethical policies or transactions, or that were previously stolen by the enemy.
16. The transfer of ownership and control of all production companies that produce ungodly, immoral, illegal or unethical productions.
17. The transfer of ownership and control of all banks, financial institutions and clearing houses.
18. The transfer of ownership and control of all real estate and everything on it, including but not limited to, all farmland, orchards and groves, all industrial areas, business districts and residential areas.

19. The transfer of ownership and control of all livestock and all animals, all insects and all creatures in the oceans and seas.
20. The transfer of ownership and control of all mining and mineral rights in the earth, including all gold, silver, precious metals and stones, and all wealth in the land and in the oceans, rivers, lakes and seas.
21. The transfer of ownership and control of all software and all hardware.
22. The transfer of ownership and control of all schools, universities, technical and training institutions.
23. The transfer of ownership and control of all resorts, theme parks and recreational areas.
24. The transfer of control of every branch of government (local, state and federal; judicial and legislative), every government program and budget and every law enforcement agency.
25. The transfer of control of all weapons (military and civilian) and every type of weapon (firearms, chemical, nuclear, etc.).
26. The complete restoration of the reverential fear of the Lord over all people.
27. Allowance for increases in the cost of living for all seven-fold double compensations.
28. The seven-fold double return of the entire value of any property attacked by Satan, his minions, or those under his influence or control, that caused any type of aggravation, inconvenience, distress or loss of enjoyment.

B. We further request that should any of the defendants or co-defendants steal, attempt to steal, or even consider stealing (Matt. 5:28) any part of the restoration, restitution, recompense or compensation paid to the plaintiffs or those whom they represent, the entire amount of said restoration, restitution, recompense or compensation shall be doubly and immediately restored and a severe punishment rendered upon all participating defendants.

The Supreme Judge, Yeshua ha Mashiach YHVH (Jesus the Anointed LORD), has been given the authority for all judgment based on John 5:22 (*“For the Father judges no one, but has committed all judgment to the Son.”*), Genesis 18:35 (Amp) (*“...Shall not the Judge of all the earth execute judgment and do righteously?”*), and Isaiah 33:22 (Amp) (*“For the Lord is our Judge, the Lord is our Lawgiver, the Lord is our King; He will save us.”*). We request that judgment be entered immediately based on John 12:31 (*“Now is the judgment of this world; now the ruler of this world will be cast out.”*) and Luke 13:16 (*“So ought not this woman, being a daughter of Abraham, whom Satan has bound – think of it – for eighteen years, be loosed from this bond on the Sabbath?”*) and that relief is granted as appropriate according to the word of the Lord.

- *Proverbs 13:22 – “A good man leaves an inheritance to his children’s children, but the wealth of the sinner is stored up for the righteous.”*
- *Proverbs 28:8 – “One who increases his possessions by usury and extortion gathers it for him who will pity the poor.”*
- *Ecclesiastes 2:26 – “For God gives wisdom and knowledge and joy to a man who is good in His sight; but to the sinner He gives the work of gathering and collecting, that he may give it to him who is good before God...”*
- *Proverbs 6:30-31 – “People do not despise a thief if he steals to satisfy himself when he is starving.30 Yet when he is found, he must restore sevenfold; he may have to give up all the substance of his house.”*
- *Isaiah 61:4-7 - 4 “And they shall rebuild the ancient ruins; they shall raise up the former desolations and renew the ruined cities, the devastations of many generations. 5 Aliens shall stand [ready] and feed your flocks, and foreigners shall be your plowmen and your vine dressers. 6 But you shall be called the priests*

of the Lord; people will speak of you as the ministers of our God. You shall eat the wealth of the nations, and the glory [once that of your captors] shall be yours. 7 Instead of your [former] shame you shall have a twofold recompense; instead of dishonor and reproach [your people] shall rejoice in their portion. Therefore in their land they shall possess double [what they had forfeited]; everlasting joy shall be theirs.” (AMP)

- *Zechariah 9:11-12 – “As for you also, because of the blood of your covenant, I will set your prisoners free from the waterless pit. 12 Return to the stronghold, you prisoners of hope. Even today I declare that I will restore double to you.”*
- *Joel 2:25-26 – “So I will restore to you the years that the swarming locust has eaten, the crawling locust, the consuming locust, and the chewing locust, My great army which I sent among you. 26 You shall eat in plenty and be satisfied, and praise the name of the Lord your God, who has dealt wondrously with you; and My people shall never be put to shame.”*
- *Isaiah 54:16-17 – “Behold, I have created the blacksmith who blows the coals in the fire, who brings forth an instrument for his work; And I have created the spoiler to destroy. 17 No weapon formed against you shall prosper, and every tongue which rises against you in judgment you shall condemn. This is the heritage of the servants of the Lord, and their righteousness is from Me,” says the Lord.”*
- *Psalms 126:4-6 – “Bring back our captivity, O Lord, as the streams in the South. 5 Those who sow in tears shall reap in joy. 6 He who continually goes forth weeping, bearing seed for sowing, shall doubtless come again with rejoicing, bringing his sheaves with him.”*
- *Isaiah 23:17-18 – “And it shall be, at the end of seventy years, that the Lord will visit Tyre. She will return to her pay, and commit fornication with all the kingdoms of the world on the face of the earth. 18 Her gain and her pay will be set apart for the Lord; it will not be treasured or laid up, for her gain will be for those who dwell before the Lord, to eat sufficiently, and for fine clothing.”*
- *Psalms 23:5-6 – “You prepare a table before me in the presence of my enemies; you anoint my head with oil; my cup runs over. 6 Surely goodness and mercy shall follow me all the days of my life; and I will dwell in the house of the Lord forever.*
- *Psalms 61:5 – “For You, O God, have heard my vows; You have given me the heritage of those who fear Your name.”*
- *Isaiah 57:13 - ... “But he who puts his trust in Me shall possess the land, and shall inherit My holy mountain.”*
- *Matthew 5:5 – “Blessed are the meek, for they shall inherit the earth.”*
- *Colossians 3:23-24 - “And whatever you do, do it heartily, as to the Lord and not to men, 24 knowing that from the Lord you will receive the reward of inheritance; for you serve the Lord Christ.”*
- *Psalms 31:19 – “Oh, how great is Your goodness, which You have laid up for those who fear You, which You have prepared for those who trust in You in the presence of the sons of men!”*
